Booth equipment

Each RBC 10' x 10' booth will be set with 8' high gray and black back drape and 3' high gray side dividers. Each OAP 10' x 10' booth will be set with 8' high blue and black back drape and 3' high blue side dividers. Booths 300 sqft or less will receive a 7" x 44" identification sign. Booths larger than 300 sqft will receive a 7" x 44" identification sign upon request.

Exhibit hall carpet

The exhibit hall is not carpeted. The RBC aisles will be carpeted in tuxedo and the OAP aisles will be carpeted in midnight blue.

Labor information

- Ensure your carrier knows the company name and booth number when making arrangements for shipping your exhibit at the close of the show.

During show checklist

On-site information

- Please arrive with enough time to set up your booth.
- Exhibitors supervising Freeman labor will need to pick up and release their labor at the Labor Desk.

Move-out checklist

Dismantle and move-out information

- All exhibitor materials must be removed from the exhibit facility by May 18, 2023 7:00 PM.
- To ensure all exhibitor materials are removed from the exhibit facility by the Exhibitor Move-Out deadline, please have all carriers check-in by May 18, 2023 5:00 PM. In the event your selected carrier fails to show on final move-out day, Freeman reserves the right to re-route your freight onto another carrier.

Excessive trash and booth abandonment

- Note that any excessive trash which consists of display materials, carpet, padding, crates and/or pallets will be disposed of and charged both a handling fee and disposal fee during exhibitor move-out.
- Clear out booth. Any excessive materials left in the booth at the end of the event will be considered trash.
