# 2025 WEFTEC International Update

## Changes Internationally

- WEFTEC 2025 is larger than WEFTEC 2024 in NSF & Number of Exhibitors
- WEFTEC 2025 has lost international exhibitor groups because of tariff uncertainty
- For 2025, our Asian exhibitor base is approximately 35% smaller, the two Ontario Pavilions as well as the Denmark Pavilion have cancelled their space this year.



# FY26 Budget

FY2025

- EPA FY25 \$9.1 billion
  - Clean Water SRF \$1.6 billion
  - Drinking Water SRF \$1.1 billion



## President Trump's "Skinny Budget"

- Budget released in May for FY2026
- EPA FY26 \$4.2 billion (-55%)
  - Clean Water SRF \$155 MILLION!
  - Drinking Water SRF \$150 MILLION
- NOAA -\$1.3 billion
- LIHEAP -\$4 billion

# US Tariff Policy Update

## Policy Direction

- Ongoing uncertainty
- US announcing new unilateral tariff rates by July 9, with possible extensions
- G7 Summit (this week) – energy security, technology development, supply chain resilience and market access

## Implications for Water Sector

- Steel and aluminum tariffs – major cost factor
- US/Mexico/Canada interdependence on component parts and steel
- Heavy US reliance on China for component parts, critical minerals, and steel
- Price increases and longer lead times

## Mexico

- Nearing deal to lift 50% steel tariffs, in exchange for capping steel imports
- Hope to finalize deal at G7

## Canada

- 50% steel & aluminum tariff a major concern
- Progress toward broad trade and security pact

## European Union

- Risk of 50% tariffs on 70% of EU exports if no deal by 7/9
- EU preparing €116B in retaliatory tariffs

## China

- New trade truce pending final approval
- Expedited rare earth exports to US
