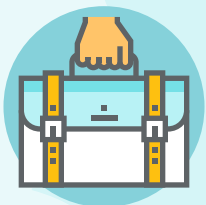

## What is advocacy anyway and Why should YOU advocate for water now?

### > Water advocacy is:

*Informing **elected officials and policy makers** of what we professionals inherently know, we produce clean, safe water and we need certain resources, legislation, and funding to do this.*

*Sharing **your passion about** the importance of access to clean, safe drinking water and sanitation.*

*Letting the general public, from school age to adult; know the importance of our day-to-day dedication and the need of their support to continue that effort.*

### > Why advocate:

*Because **YOU** are the expert when it comes to understanding water issues.*

*Support for our profession is something that will come through continued advocacy by you, our members. Your efforts, big or small can make that happen.*

*If not **YOU**, then **WHO?**!*
