2. Definitions

TERMS and CONDITIONS

- a. "Licensed Product" means the version of the Water Environment Research journal in object code accessible on WEF's Internet website.
- b. "Authorized Users" means only the employees, faculty, staff, and students officially affiliated with the Subscriber at the Authorized Site, and persons with legal access to the library's collections and facilities at the Authorized Site, using an IP address within the range identified in the Appendix (page 5). Authorized Users may be persons remote from the Subscriber's physical location whose access is administered from the Authorized Site, but not persons at remote sites or campuses or, employees of a branch campus or facility in another city. Subscribers that wish to include more than one physical location in their subscription should contact WEF.

3. License Granted

WEF grants to the Subscriber and Authorized Users at the Subscriber's Authorized Site a renewable, nonexclusive, nontransferable license to access the Licensed Product. The Subscriber will exercise reasonable vigilance and shall be responsible for all access control and security measures necessary to ensure that the Subscriber's IP addresses are not used to access the Licensed Product by other than Authorized Users. 6. Prohibition on Certain Uses
